Comparative Law in a Global Perspective

Days: June 8 to 22, 2022

Credits: 4

The course approaches comparative law and legal studies from a global perspective. It provides students with an overview of the most important legal traditions of the world, questioning state-centered paradigms and investigating current legal transformations. The first part of the course focuses on the meaning of comparative law and introduces fundamental concepts, such as those of legal traditions, legal transplants and legal pluralism, considering legal globalization as one of the most important developments for contemporary legal studies.

Public International Law In Context: a view from Latin America

Days: July 18 to 29, 2022

Credits: 4

This course introduces and explores the main topics of public international law with particular attention to the Latin American context. It examines the nature and structure of international legal arguments in historical perspective and contemporary practice, considering the regional experience of Latin America. The course's central assumption is that international law looks different in different locations of the world, despite the universalist pull of the international legal argument. In this setting, the course will analyze the fundamental elements of international law concerning the particularities of the Latin

American context. Specialized international law regimes will also be assessed in connection to specific issues of the regional experience. **+INFO**



International Investment Law and Arbitration: a political economy perspective

Days: June 8 to 22, 2022

Credits: 4

This course aims to teach students the basics of investment treaty arbitration and introduce them to techniques for studying these fields through the lens of political economy. By pairing theoretical readings of political economy with papers on substantive investment law and investment arbitration cases, the proposed course will simultaneously teach students substantive investment law, political economy analysis of law, and economic development. Substantive investment law will continuously be explained historically and analysed through the lens of political economy. The historical approach allows studying important precursors to investment arbitration (Greenman 2018; Barton 2014) as well as the modern emergence of investment law (St John 2018; Pauwelyn 2014). By contextualizing the emergence of the regime with the ideas that has served to justify it (Röpke 1954; Plehwe 2015; Kennedy 2006; Krever), students will be introduced to tools for analyzing economic thinking in legal institutions more generally. +INFO

This course aims to provide students with an overview of issues relating to the relationship between developments in digital technologies and transformations in law and governance. The course's approach is interdisciplinary and global. It will introduce students to theoretical frameworks for examining the mutually interactive relationship between technology, law, and social order, where technology is both an object and source of governance. **+INFO**

Structuring security packages in business, commercial and financial transactions: a comparative assessment of the law and practice in Colombia and the United States


In many business, commercial and financial transactions (M&A, leasing, corporate financing, project finance, commercial lending, purchase order finance) one of the parties requires the other to procure a personal and/or corporate guarantees or to grant a security interest or security package over certain assets and/or rights to secure performance of its contractual obligations. And among many available options, the selection of the guarantees and securities to be granted, depends on many variables that need to be assessed carefully in order to choose the "best possible guarantee and security package" from a cost-benefit perspective. To that end, the parties must consider elements such as tax implications, costs associated with granting and maintaining the security package, enforcement costs, efficiency and efficacy of enforcement, effects of insolvency on the security, among other aspects. +INFO
