

CALL FOR APPLICATIONS FOR POSTDOCTORAL FELLOWSHIP IN LAW 2020

(one placement)

Eligibility

- To hold a S.J.D. or J.S.D. awarded in the last five years.
- Full-time availability.
- Exclusivity-clause with Universidad de los Andes.
- Spanish proficiency.
- Residence in Bogotá is mandatory throughout the year.
- Starting date: July of 2020.

Application materials

- Syllabus proposal of one of the Basic Cycle courses of the undergraduate degree in Law of Universidad de los Andes.
- Research proposal within a two-year plan: this should include activities and achievements expected in each period and must be explicitly linked to one of the School of Law's research projects, particularly, to one of the research clusters. The applicant should discuss the research proposal with the cluster coordinator.
- Curriculum vitae.
- Motivation letter.

Application materials should be submitted in Spanish.

Application procedure

- Application materials (Letter of presentation of the candidate addressed to the dean, up-to-date resume, copy of undergraduate and postgraduate degrees, accreditation of experience in teaching and researching in the areas of their specialty through certification issued by a University or research center, proposed program of one of the courses of the basic cycle of the undergraduate law of Universidad de los Andes, proposed work in researching for one year, clearly separating the achievements and activities of each proposal) should be sent through the following link: <https://es.surveymonkey.com/r/posdoc> , at the latest by February 14th of 2020. Incomplete or out-of-deadline materials will not be considered.
- The Selection Committee (conformed by the S.J.D. Director, the Undergraduate Program Director and the Socio-Legal Research Center [Cijus] Director) will select the pre-candidates based on their merits and achievements and eventually conduct interviews with them.
- The Selection Committee will present their preliminary evaluation and conclusions based on the application materials and the interviews conducted to the Faculty's Council, which will take the final decision on the elected candidates and the order in which the offers will be made.

Description of the Postdoctoral Fellowship

- Full-time employment contract/contract of service including exclusivity-clause for 11 months, renewable for one more year. The renewal's decision will be made by the Faculty's Council.
- Will be supervised by a professor assigned by the Selection Committee.

The applicant is expected to

- Support her/his/their research cluster on building external financing projects.
- Dictate at least one course within the semester, and maximum two courses within the year.
- Publish one article in any journal located in quartiles Q1, Q2 and Q3 of Scopus and/or Scimago during the first year. If the Fellowship is renewed for a second year, the applicant should publish an additional article. During the building of the application research proposal, this aspect should be taken into account.
- Actively participate in the Cijus Workshops and Doctoral Colloquiums. The applicant is expected to present her/his/their research work at the Doctoral Colloquium at least once during the Fellowship.
