Max Planck Law maintains a Social Science Research Network (SSRN) Research Paper Series and consistently ranks highly in a number of SSRN criteria for top international law schools.

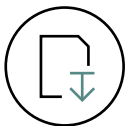

## How We Support Your Career

*Max Planck Law offers a range of resources and opportunities to support your research, whether you are working towards a PhD, embarking on a postdoc project, or leading your own research group.*

As a researcher at one of our Institutes, you will have access to excellent resources, including specialized libraries and databases, as well as support from administrative and academic staff.

In addition, you will benefit from funding for research-related expenses such as travel costs, conference fees, and publication costs. We provide career coaching, organize exchanges with leading international law faculties, and help you promote your research globally.

You can also access German language courses, onboarding services, and family services to assist with,

for example, childcare.

The Max Planck community is a globally respected network of researchers with a wealth of experience and knowledge. Being part of this network provides a strong foundation for your professional future.

We believe that by providing you with both access to a valuable network of researchers and the necessary financial resources, you will be able to focus on what really matters: pursuing your passion and making a meaningful impact in your field.

### FUNDING

PhD students at our Institutes receive a three-year contract and a minimum salary of € 3,000 per month before tax. For postdocs, the initial contract is a fixed-term appointment for two years which can be extended twice, up to a maximum of six years. The annual salary before tax will be on a scale from € 58,000 to € 83,000 for a full-time position, depending on prior experience. The Institutes facilitate mobile working through local agreements. The positions also include an annual bonus, access to state benefits, and 30 days annual leave.





## *This is what you can achieve with us:*

**AS A PHD STUDENT,** you will have the opportunity to work towards your doctorate in a supportive and diverse environment. Your status as an employed researcher will allow you to entirely focus on your PhD project.

**AS A POSTDOC,** you will carry out independent research with the guidance and support of an Institute Director or Research Group Leader. This will allow you to enhance your research skills, build your expertise, and establish yourself as an internationally recognized researcher.

**AS THE HEAD OF A RESEARCH GROUP,** you will be responsible for managing your group's research and activities, and for completing a major project.

### LIVING AND WORKING CONDITIONS

Germany is widely known for its comfortable lifestyle and affordable living costs. It is a highly sought-after global destination, offering a range of benefits such as excellent healthcare, reliable infrastructure, a clean environment, stunning scenery, and vibrant cities, all contributing to an enjoyable living experience.

Moreover, Germany is considered a secure place to reside, providing a safe and stable environment for its residents. Today's Germany is a cosmopolitan and diverse society, with over 25 % of its population being migrants or descendants of migrants.

### VISA AND WORK PERMIT REQUIREMENTS

As an EU citizen, you already have the right to work in Germany. If you are joining us from outside the EU, with a job offer or visiting researcher contract you will qualify for a settlement permit for highly skilled workers or for an EU Blue Card.

If you move to Germany with your partner, they will be eligible for a working visa and for financial support with language courses. Additionally, any children will be eligible for financial support.

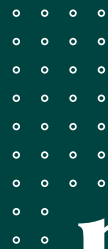
