### Pedagogical approach

- Take-home assignment (criteria: problem formulation, structure and presentation, knowledge and insight into the topic, investigation and analysis, argumentation and conclusions, independence of thought, critical thinking, language and formal requirements, ability to comply with the given timeframes and word count).

# Explanation of the Course's relevance and its connection to contemporary global issues

This proposed course on "The Protectionist Comeback: from Free Trade to Trade Wars" deals with one of the most important contemporary issues in the global legal landscape: the current protectionist wave against free trade, and the increased likelihood of trade wars after Mr. Trump reelection to the Withe House.
